

CARDED WORKFORCE POLICY – Revised July 2019

Introduction

Bellway is committed to operating a fully qualified workforce on all its sites. Industry card schemes provide a mechanism to verify competence and qualifications, therefore we require all employees and sub-contracts engaging in construction related activity to hold the appropriate card.

1. Bellway Employees & Sub Contractors

Requirements are for all construction, site based or those regularly visiting sites to have the most relevant card. Sub-contracts are expected to meet or exceed our requirements. See Table 1 – Relevant cards for job roles.

2. Affiliate Card Schemes

Bellway recognise CSCS as being the preferred industry card scheme however, cards may be accepted from schemes listed in Table 2 Affiliate Card Scheme.

3. Requirement for a card on site

Construction related activity

A card should be provided as proof for workers who carry out construction related activities.

Non-construction related activity without a card

The site manager has the responsibility to induct and ensure safety at all times when on site.

Companies providing non-construction workers on site, such as cleaners, must produce evidence they have safe working practices, risk assessments and staff are adequately trained for safe working practices.

4. Checking authenticity of cards

As a visual check is not reliable, it is important checks are made to ensure the card is valid and genuine.

5. Recruiting site employees

The recruitment manager has the responsibility to check cards are genuine by using the above methods for checking validity.

6. Acting on discovery of a fake card
